Exhibit 8 contains a true and correct depiction of the results that I viewed when I entered those terms in the Google search box. On the CD, I narrated what I was doing during the course of the searches. The description of the steps I took which is contained on the narration on the CD is a true and correct description of what I did. The images on the CD are a true and correct recording of the images that I viewed and recorded.
- 5. On this CD, in the folder entitled "Perfect 10 Experience," I recorded the steps I made in viewing on the Perfect 10 website some of the same images as I had viewed using Google. All of the images shown in the "Perfect 10 Experience" are

images that I viewed on the website www.perfect10.com.
